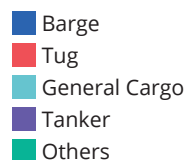
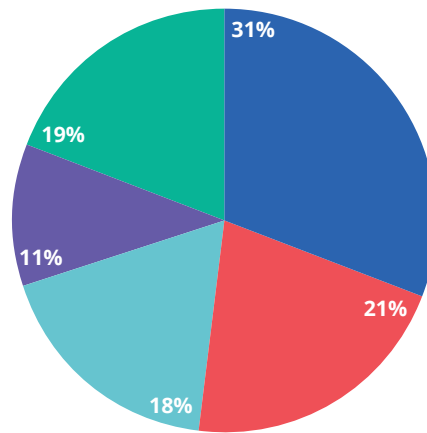

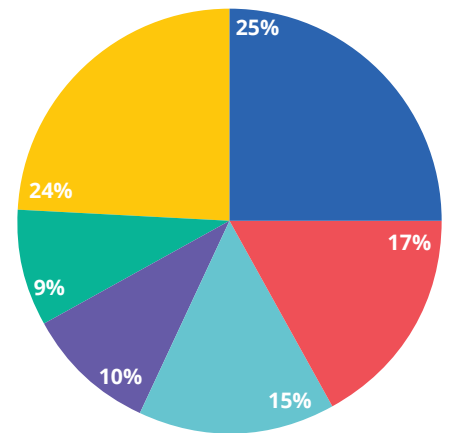

### BY SHIP TYPE

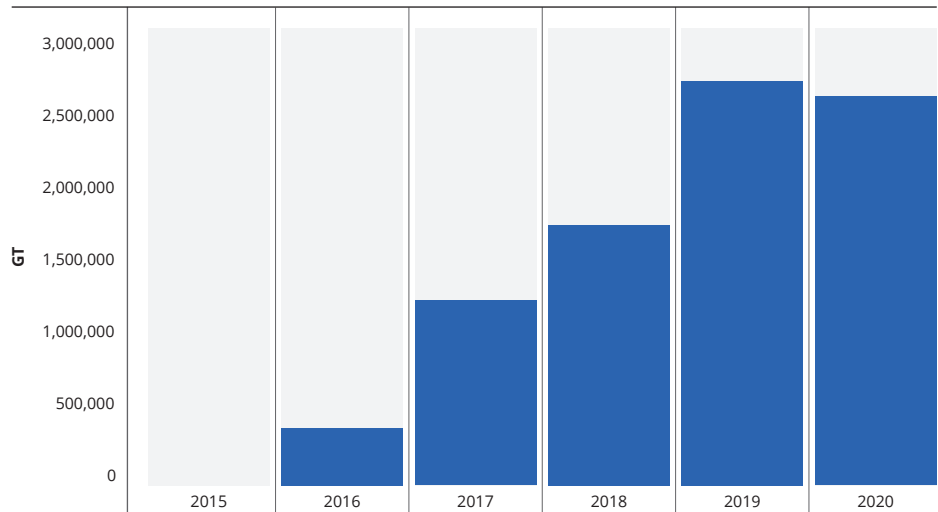


### BY PLACE OF MANAGEMENT

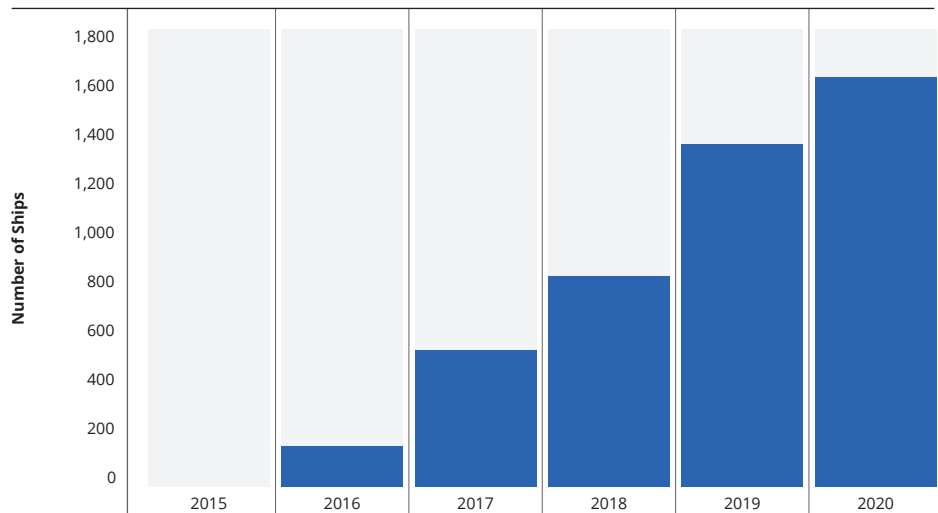
