P&I Membership update

The London P&I Club has recently concluded the 2019 renewal. Key developments in the Club's Membership are summarised below, along with an outline of other recent Club news featured in this edition.

Following the renewal completion, the Club saw encouraging year-on-year growth of 3.5m gt – or more than 7% – in its mutual-owned entry. Reto Toggwiler, director of underwriting, says: "Controlled growth in the Club's mutual book of business is a central part of our underwriting strategy, and it is pleasing to see the entries that we have received from new and existing Members over the last 12 months and around the recent renewal.

"In the challenging and uncertain trading environment that Members continue to face, the importance of reliable and understanding P&I support comes ever more to the fore. This appears to be reflected by the continued growth in the Club's Membership."

Reto adds: "We were delighted to welcome new Members to the Club throughout 2018, as well as at 20 February when 13 new fleets attached, comprising different ship types from countries including China, Greece, India, Indonesia, South Korea, Singapore and the USA.

"In addition to the growth in the Club's mutual Membership, good progress continues to be made in our other lines of P&I business resulting in a total combined insured tonnage of over 60m gt. These developments are encouraging as the Club heads into the new P&I year. We take this opportunity to thank Members and brokers for their support of the Club's work."

Steve has also been heavily involved in several in-house presentations that the Club has recently provided to visiting student delegations. The London P&I Club was one of the 11 International Group P&I Clubs attending this year's 18th International P&I Conference in Greece, organised by Evmar Marine Services and the Piraeus Marine Club.

The speakers and audience at the event held at the end of January debated a range of topical industry issues, including the 2020 global sulphur cap and the value of Clubs diversifying their activities into non-mutual lines of business.

The London P&I Club was represented by claims director, Steve Roberts, who was one of the speakers discussing the Maritime Labour Convention (MLC). The audience was asked whether the certification issued by the Clubs can present potential for conflict in some circumstances.

Often referred to as the "fourth pillar" of the maritime industry's regulatory framework, the MLC was adopted by the International Labour Organisation in 2006 and came into force in August 2013. Its purpose is to establish minimum living and working standards for all seafarers

on ships flying the flag of a ratifying state, and extends to lost wages and repatriation if their Shipowner employer becomes insolvent.

Club cover extends to some risks covered under the MLC, but not all. For example, although cover responds to medical treatment following an injury onboard, it does not extend to customary wages. Since January 2017, ships are required to prominently display certificates issued by an insurer or other financial security provider confirming that insurance is in place for the key MLC entitlements, including those following abandonment due to the Shipowner's insolvency. While the insolvency-related liabilities to be certified fall outside of customary P&I cover, the Shipowner Boards of all IG Clubs decided it would be more practical and cost-effective for them to issue the required certification. The certificates are provided on the back of a separate reinsurance purchased for claims in excess of US\$10m.

MLC certification remains a relatively new development, but it was apparent from the speakers' presentations that the IG has collectively already seen about 40 abandonment cases. Most presented some difficulty in resolving, which indicates that the MLC's objectives are not always proving easy to deliver. Several practical impediments were identified.

It was agreed by speakers and audience that, although there was potential for conflict, implementation of the MLC is of paramount importance to ensure the well-being of seafarers, the backbone of the global shipping industry. Despite the difficulties, most of the problems encountered could be resolved in time through effective case handling or the sharing of experience with its authors.

The consensus among the speakers was that the Clubs remain best placed, in terms of resources, knowledge and cost, to continue facilitating the certification process, as well as helping resolve cases of seafarer abandonment. Most also agreed that it will be helpful for Clubs to share their experience with the regulators to help improve the effective delivery of all the intended benefits to innocent seafarers.

Club welcomes students from Greece

The Club's London staff were delighted to welcome delegations from the Alba Graduate Business School at The American College of Greece in Athens and the Department of Maritime Studies at the University of Piraeus.

The two recent visits included an introduction to P&I insurance and the Club's work, followed by a case study provided by claims director, Steve Roberts. This highlighted the wide range of risks and claims handling issues, including pollution and wreck removal, which can be involved in a shipping casualty. The students also met with members of the Club's claims team.

The feedback from both delegations was very positive, and we trust the students enjoyed their overall programme of other visits in London.

My involvement helped me know more about the different developments in China, and it was an unforgettable experience to be the one of people serving in the first Olympics Game held in China."
